- We do not and will not develop or promote any European certification mark which competes with the KEYMARK.


Upon receiving empowerment from the Management Organisation, we agree to:

- Recognize and accept the validity of KEYMARK licences issued by other empowered certification bodies.
- Participate to the meetings relevant to the operation of the KEYMARK scheme.

• The application form shall be submitted in English, preferably by e-mail.

Accompanying supporting documents translated in English too will speed up the handling of your application.

- Provide together with your application form copies of the following documents:
  - Your scheme rules (if these are not the KEYMARK scheme rules approved by CCB)
  - Your valid EN ISO/IEC 17065 accreditation certificate including the relevant scope
  - Accreditation certificates of your subcontractors (testing laboratories and inspection bodies) if they are not yet recognized/approved by the KEYMARK scheme group
- Send the application and supporting documents to DIN CERTCO.
- DIN CERTCO will do the assessment in accordance with the CEN-CENELEC Internal Regulations – Part 4 "Certification" (2014-01)
- After positive result you will receive the new Certificate for Empowerment and in case of a first empowerment the Licence Agreement for signature.
